Quorum: A quorum (>7) of ABS Directors was determined to be present, including Zoom attendance. Count = 8.

Approval of the 2023 Board meeting minutes: Unanimously approved.

Agenda: One addition: Magazine purchase online, ISSUU.com website (under "New Business").

Consent Agenda: The following items were included in the Consent Agenda:

Species/Source List Report; Bambooweb.info Report. These are attached to these minutes.

The Consent Agenda was approved unanimously on a motion by King, second by Edwards.

Chapter and International Reports (information only, as available) are **attached**.

President's Comments: (Luc Boeraeve) - full report attached.

Treasurer's Report: (Carole Meckes) -

The YTD income/expense report through 1 October 2024 and the proposed budget for 2025 were presented.

YTD Income \$27,063.19; Expenses \$23,156.11.

Cash balances in checking and PayPal total \$20,181.84. With \$101,374.00 in the Charles Schwab brokerage account, less liabilities of \$1890.00, makes the ABS net worth \$119,665.84.

\$5000 for grants had been allocated for 2024 and forwarded to the Ned Jaquith Foundation.

The annual audit of ABS accounts by the Secretary was accomplished by comparing recent bank and brokerage statements to the amounts in the Treasurer's reports. No discrepancies were found.

The final 2025 budget and discussion appear under New Business below, following the internal funding requests.

A motion (King, second by Boeraeve) to approve the Treasurer's Report carried unanimously.

Management of Funds in Brokerage Account: (David King) The invested funds are divided among 1 government money market fund and 4 exchange-traded funds. YTD, the brokerage income is \$2854.75. King rebalances the investments from time to time to maintain diversification and a moderate risk allocation. Volunteers to help manage the account would be welcome.

Membership Report - (Carole Meckes):

There are currently **398** voting ABS members, and Carole presented the breakdown among chapters. Thus the quorum for the Annual General Meeting will be **40** or more ABS members. Discussion of how to ensure ABS Life Members are still alive resulted in consensus that periodic email contact should be attempted, with a response considered a "sign of life".

Secretary's Report (David King)

A summary of Board actions (via Zoom meetings) since the last Annual Meeting is attached.

At-Large #2 Director for 2024-2027 term: Election results to be announced at the upcoming Annual General Membership Meeting.

LGCC: Judge Edwards re-elected.

PNWC: PNWC Board to meet in Dec 2024, incumbent Ian Connor is Acting Director in meantime.

TBSC: To be decided at a Chapter meeting after the ABS conference.

Ned Jaquith Foundation (NJF) Grants: (Nancy Oberschmidt) Grant application deadline was 1 October and 8 grants have been awarded for 2025, totaling \$26,790. The Ned Jaquith Foundation reviews and approves grant applications received on behalf of the ABS. Donations are solicited, as always.

Arts & Crafts Report: (Shanti Pierce) [No report]

NEW BUSINESS —

Annual Review of Electoral Number (David King): The number of <u>primary</u> ABS members which a chapter must have to be represented by an ABS Director is currently <u>20</u>. <u>Twenty</u> ABS members are needed to form a chapter. Chapters which are not large enough to have their own Director are represented by the five At-Large members or may share a Director with one or more other Chapters.

A motion (King, second: Edwards) to keep the electoral number at 20, carried.

ABS 2025 Annual Meeting Update: ABS Meeting Planning Committee

Location: Greenville, SC. Has a major airport, short distances to bamboo groves.

Dates: Late October 2025, likely 30.Oct – 2.Nov.

Host: ABS, assisted by members of the Southeast Chapter.

Meeting hotel: Embassy Suites is first choice.

Program: Thursday: Board meeting. Friday: Clemson experimental grove, speakers. Saturday: Robert Sutton's Henon grove, Bamboo Bill; structure building (?design competition); native bamboos in the grove. Sunday: optional tours. Details on bamboo.org as they are developed.

Estimated cost of meeting = \$18,000. James Clever will email the cost breakdown to the Board, with approval deferred until the later 2025 budget discussion.

James offered, and Ian accepted, the primary role in directing the annual meeting planning team in the future.

ABS 2026 Annual Meeting: ABS Meeting Planning Committee

Various options discussed including Texas, Hawaii and Puerto Rico.

Advertising:

Chair position vacant; Carole Meckes maintains an advertiser spreadsheet.

Judge Edwards volunteered to assume the advertising duties with assistance from James Clever (former Chair) and Carole.

Website: Carole Meckes

FAQ page – needs more than the single question on the page that is there now. Judge urged the whole Board to contribute questions and answers. David noted that there are unpublished pages from the oldest ABS website which might be helpful, and several online bamboo nurseries have FAQ pages which we could ask to adapt for ABS use.

WBO Website Integration: Luc Boeraeve

The new WBO website has a page dedicated to the ABS as a sponsor. ABS promotion could be included there, and a video would have considerable impact. Luc will ask Shanti Pierce if she would put a video together since she has experience.

Bamboos Native to the US: Luc Boeraeve

Luc stated the ABS should make ABS members aware of the native bamboos to the US, for example through presentations at meeting. Contacts with others who might be helpful to these efforts should be established. James and Daphne suggested contacting meeting speakers who spoke about native bamboos and ask about their contacts.

Florida Bamboo Growers Association: Luc Boergeve

It is not clear where this bamboo farmers' organization stands with respect to numbers of plantings and number of farms. ABS should cooperate with them with information exchange.

BAMBOO Magazine: Carole Meckes, Mark Sanders

At Mark's suggestion, the Board considered using the ISSUU.com site to convert ABS publication PDFs to a flipbook format for the website. The cost is approximately \$250/year. There is a limited free version available as well. A **motion** by Judge Edwards to approve this amount was proposed, then amended by King to try the free version first as a trial. The amended motion was seconded by Judge and received unanimous Board support.

Publications Chair Retirement: David King for Michael Bartholomew

Michael Bartholomew has been managing ABS publications for many years and is considering winding down his involvement. In addition, he stores many back issues of newsletters, magazines, journals and source species lists at his residence and asks for guidelines as to their disposition.

The Board expressed a need for a timeframe as well as a count (number of boxes) of what is stored, and discussed keeping 6 complete sets and recycling the rest. Michael has invited anyone to pick up, in person, as many copies of publications as desired in the meantime.

Michael strongly suggests consolidating publication, printing and mailing functions in one local area to avoid shipping delays.

The question of whether the annual honorarium will continue for a new publications chair was deferred.

ABS Internal Funding Requests: (For final figures, see line entries in attached budget.)

Web/Internet: no new requests.

BAMBOO Magazine – no significant change. Species Source List – funds carried over.

Arts and Crafts: no new requests.

APPROVAL of the 2025 ABS BUDGET (*All Directors and Officers*): After a **motion** (King, second: Boeraeve) and extensive discussion, the 2025 budget was **approved** unanimously.

Announcement of International Events: Luc Boeraeve

Luc notes that there are more and more bamboo events being scheduled around the world.

2025 - WBC 13: The presumptive location of the next World Bamboo Congress is in Brazil. Discussions are in the early phase, but the dates possibly will be in Brazilian late winter or spring (August or September 2025).

2025 – A Bamboo Expo in the US is in the works for autumn 2025, likely in Florida. Ideally it would not conflict with the dates of the 2025 ABS Annual Meeting.

Future ABS Annual Meeting Planning:

2025 - Greenville, SC - hosted by the ABS.

2026 - (Options being discussed: Texas, Hawaii, Puerto Rico.)

2027 - (Need location.)

Future ABS Board Meetings: Will be continued online as needed throughout the year.

Approval of the 3 November Annual ABS General Meeting Agenda was by consensus.

Item continued until the Board reconvenes:

The election of officers of the ABS.

Recess: At 1600h, a **motion** (Boeraeve, second: King) to **recess** the meeting of the Board until 18 October 2024 at a time after the Annual General Meeting gained unanimous approval.

ABS President's report for the year 2023 - 2024

The online regular board meetings of the American Bamboo Society keeps the society in good shape as well as the once a year in person board meeting prior to the AGM and annual conference. 5 board meetings via Zoom were held since last year's AGM (01/21, 03/10, 05/19, 07/07, 09/01). In addition there were Tech Committee meetings and a committee for organizing the annual conference without a chapter hosting it. Although such a conference, organized by the ABS Board, was planned for 2024, the Ned Jaquith Foundation and the Pacific North West chapter actually took charge of the 2024 ABS conference taking place at the Missouri Botanical Garden in St. Louis from 17 to 20 October.

As there is no chapter ready to organize the 2025 ABS Conference, the conference committee, reinforced by members of the South East Chapter (SEC) chapter is preparing next year's conference.

The regular Zoom meetings help to maintain close links between the chapters and the board and to ensure that any issue popping up can be dealt with in a timely matter. It is also helpful for the organization of the annual conference as the organizing chapter can draw on the experience and support from other chapters and from board members.

The administrative management of the society went smoothly in 2024. The website continued with a few changes although it is the intention to include more 'bamboo' information from the previous websites. An archive, accessible through the website bamboo.org, makes the ABS Journals from 1980 to 1991 available to the general public. It is planned to make all, old and new, bamboo magazines available on the website although issues from recent years would only be accessible for ABS members.

Bamboo, the ABS magazine, continues to be in full color and this is much appreciated by the members.

The previous edition of the Bamboo Species Source List N° 36 (2017- 2018) is being updated and should be ready for distribution next year.

Following previous years' successful competitions, the arts and crafts committee launched another competition in 2024 with the winners to be announced in Fall.

As in previous years, the Ned Jaquith Foundation is launching and managing the annual research grant scheme co-financed by the ABS. The winners of the current year will be announced in October 2024.

The World Bamboo Organization has revamped its website to make it more professional and to attract a wider audience. The Board decided to financially support the WBO and the ABS has now one page on the WBO website with the possibility to include one video on its page.

A good indicator of the health and attractiveness of the ABS is the increase in membership. The number of members has been going up during the last two years and reached 400 in September 2024.

The above is a short summary of what happened and was done this year but much more work has been and is being done by many, both members of the board as volunteers, such as overlooking the printing and distribution of the Bamboo magazine, editing the ABS Journal, Website content and

- 6. The 2025 ABS Annual Meeting and Conference is planned for Greenville, South Carolina in mid-October. The tentative theme is "In the Groves". John and Michelle Tkach have been doing groundwork. A basic outline includes a 3-day program with tours of bamboo groves near Greenville.
- 7. ABS will become a sponsor of the World Bamboo Organization at the \$1000 per year level.
- 8. ABS membership reached 400 by 1 Sep 2024.

The LGCC chapter held its annual Bamboo weekend on Avery Island during the last full weekend of February 2024. The meeting was held on February 23 at the Hampton Inn and suites in New Iberia Louisiana. Two new board members were elected to our board at that time. Kathleen Whitehurst and Deborah Namas are our newest board members and are welcomed with great enthusiasm. The meeting was well attended, and our Grove grooming was pleasing to both the groomers and the Grove owners.

The following May 2024, our newest Director, Kathleen Whitehurst, organized a Bamboo furniture building workshop featuring James Wolf in Arnold Ville Louisiana, just north of Lafayette. Highlights from 2023/2024 — Prepared by Kay Koppedrayer, SEC Chapter President

Members of the Southeast Chapter were again busy with their bamboo work. Here are some highlights from 2023.

January 28: Open House at the Koppedrayer Bamboo Farm in Odum, GA. Sadly, no one came!

February 24: Savannah's Historic Bamboo Farm at the Coastal Georgia Botanical Gardens on Candebrake Rd.

Daphne Lewis, Kay Koppedrayer, & Lynday Kleinknecht worked in the Vivax grove near the pavilion cutting & hauling out the dead culms. WE managed to clear up the front section of the grove.

February 26: Annual meeting of the Southeast Chapter via Zoom.

Nine members attended. April 1. April 1: Three Chapter members, Mike Hotchkiss, Walter E. Campbell and Kay Koppedrayer, convened a panel, "Bamboo in Georgia's Landscape: From Native Americans to the USDA," at the 2023 Georgia Archives Symposium. The presentations were well-received. Bamboo appears in many places in the Georgia landscape. You see it along roadways, in fields and yards. Some stands look to be feral; other plantings intentional. But for all its prevalence, there is little public understanding of bamboo's history in this state and its relationship to native versus invasive species. This panel will bring some of that history to light. The first presentation examines the diminishing presence of the native species of bamboo commonly known as rivercane. From there, attention turns to the late 19th- and early 20th-century efforts to introduce foreign species of bamboo to the American South. The third presentation takes up the implications of the USDA's project to make bamboo a viable cash crop.

June: Kay Koppedrayer's Cooking with Bamboo was published.

June 24: Daphne Lewis went to the Moso grove at the Silverbrook Cemetery in Anderson, SC, to spray herbicide to kill the wisteria choking the bamboo.

July 12: Kay Koppedrayer went to Savannah to check out the Madake grove at the Historic Bamboo Farm. The bamboo is not doing well. Will Savanich believes that environmental factors, including pollution from the adjoining highway is affecting the bamboo.

Oct. Boofest every weekend at the Holmes Bamboo Farm in Unadilla.

The brainchild of Ryane Holmes & Jess Brym. A fabulous use of a Moso grove. Nov. 3-5: The annual gathering of the American Bamboo Society in New Iberia, Avery Island, & Jefferson Island, LA, organized by members of the Louisiana & Gulf Coast Chapter. Good sessions on Friday, beautiful day on Avery Island, much bamboo building at the Rip Van Wrinkle Gardens on

Sunday. A good time was had by all. December 5: Kay Koppedrayer checked in with the staff at Savannah's Coastal Georgia Botanical Gardens regarding the change in leadership there. For now, the site will continue as an event venue & botanical gardens. December 9: Magical Christmas Light walk at the Holmes Bamboo Farm in Unadilla, GA. Another event masterfully organized & coordinated by Ryane Holmes & Jess Brym. Well worth attending. Bamboo vendors welcome.

Feb. 11: Dr. Mark Czarnota, Department of Horticulture, University of Georgia, forwarded to the Chapter the list & map of Bamboos at the USDA site in Bryon, Georgia. Feb. 24-26: A couple of members of the SE Chapter participated in the Avery Island Moso Grove Grooming sponsored by the Louisiana-Gulf Coast Chapter.

March 1: Several members of the Chapter (Tracy Cato, Daphne Lewis, Jaap Koppedrayer, & Kay Koppedrayer) traveled to the UGA campus in Tifton, Georgia, to check out several large bamboo groves planted in circa 1967.

March 5: Annual Southeast Chapter Meeting, via Zoom.

April 8: Daphne Lewis & Kay Koppedrayer ran a workshop on growing & eating bamboo at the Coastal Georgia Botanical Gardens at the Historic Bamboo Farm in Savannah, as part of their Backyard Gardening Series.

May 20: David Benfield of Brightside Bamboo presented a class on bamboo basics at the Sarah P. Duke Gardens at Duke University, Durham, North Carolina.

May 27th Lawton Rogers hosted a 'Biochar burn' party

- ✓ 2023- 2024 was my third year of my 4th 3 year term as International Representative and Director of the ABS.
- ✓ This was an extremely busy year during which I participated in many bamboo events and had a lot of contacts with bamboo people from all over the world.
- ✓ Maintained close contact with the German, Dutch, French, UK and Iberian bamboo societies and with, being the secretary and activity organizer, the Belgian Bamboo Society and its members.
- ✓ Attended the World Bamboo Conference (18 to 22 April) in Taiwan and participated in the post Conference tour (23 24 April 2024).
- ✓ Visited Damyang, South Korea, during the annual Bamboo Festival (11 May 2024).
- ✓ Participated in the first 2024 half yearly bamboo garden and nursery visit organised by AEB France (French bamboo organization). This 2 day event took place in the vicinity of Limoges during the weekend of 25 26 May 2024.
- ✓ Attended the annual general meeting of EBS-D, the German bamboo society, during the Sommerfest (Summer festival) in Mönchengladbach in the first weekend of June. The 'Sommerfest' included visits to a Castle garden, a tree fern nursery and a Sequoia farm.
- ✓ Attended the second European Bamboo Expo, held in Dortmund, Germany on 17 and 18 May, 2024. Commercial companies and NGO's presented their products and projects in this exposition combined with lectures during this 2 day event.
- ✓ Attended the 'Bouw met Bamboe' (Build with Bamboo) symposium in Rotterdam, The Netherlands on 20 and 21 June 2024. This was mostly about architecture and designing with bamboo and promotion of planting bamboo in Europe.
